# EUROAVIA International – Application and cancellation rules – FLY-IN PARIS SALON DU BOURGET

## **Participants**

The number of participants for the FLY-IN PARIS SALON DU BOURGET is 25.

Two of the spots for the participants are reserved: one is for a WG member, and another one for the IE tutor of the event.

## **Application rules**

To apply as participant of the event, you must fill the form available on the website fly-in-paris.euroavia.eu.

During both round, the applications are processed in a "first come-first served" way. Priority will be given to the first two (2) members of each (P)AS/AM.

For the spot reserved for the WG member, priority will be given to the first (1) member who applied.

#### 20th of February 2025 at 17:00 UTC

The first round of applications opens.

#### 13th of March 2025 at 17:00 UTC

The first round of applications ends.

#### Until 21th of March 2025 at 17:00 UTC

Confirmation emails for the applicants will be sent to each (P)AS/AM/WG. Once the membership is confirmed, personal confirmation emails with a reminder of the cancellation rules plus the payment information will be sent to every accepted participant in this first round.

#### 27th of March 2025 at 17:00 UTC

The second round of applications starts.

The second round of applications will be opened in case:

• the minimum number of participants is not reached.

#### 17th of April 2025 at 17:00 UTC

The second round of applications ends.

# EUROAVIA International – Application and cancellation rules – FLY-IN PARIS SALON DU BOURGET

If there are still vacancies, they will be filled with the people on the waiting list always following the same criteria as above.

## **Payment**

The participation fee is 100€ (EUR 100). It covers 4 nights (19th to 23<sup>rd</sup> June 2025) of accommodation, every meal, including welcome dinner and final dinner, and transportation to the venue(s) of the event.

The payment information regarding the participation fee will be provided to the participants via email, once confirmed.

Arrival and departure will be paid for by the participants and must be arranged by them.

EUROAVIA Paris will not provide accommodation outside of the event dates. However, if a participant needs to stay extra days, EUROAVIA Paris will assist them in finding proper accommodation.

### Cancellation rules

In the case that a member has been confirmed by the organizing committee to participate in the FLY-IN PARIS SALON DU BOURGET but, for any reason, is unable to participate in the event, there is an option of canceling the participation.

In order to do so, the member will have to send an email to <u>andrea.rambourg@euroavia.eu</u> stating the reason for the cancellation and the participation fee will be partially/fully paid, based on the following criteria:

Period of cancellation	EVENT NAME cancellation fee to be paid
Before the 10/04/2025 at 17:00 UTC	0%
24 <sup>rd</sup> of April 2025 at 17:00 UTC	25% <b>(25 €)</b>
08 <sup>th</sup> of May 2025 at 17:00 UTC	50% <b>(50 €)</b>
From 22nd of May 2025 at 17:00 UTC	100% <b>(100 €)</b>

If the member cancels their participation, the respective Local Group or WG is responsible for transferring the cancellation fee to the event organisers, under the condition that their place cannot be filled by someone else on the waiting list.

Participants on the waiting list that are admitted due to cancellation will have the possibility to cancel within one (1) week from receiving the acceptance email without paying a cancellation fee.

After this week, the cancellation fee will be according to the periods listed above.
